## CANCELLATION & RULES

**Security Deposit** A security deposit of **\$500.00** is charged before your trip begins. It is returned 7 days after the trip ends unless any damages need to be assessed.

**Cancellation** For a full return of the deposit, you have 30 days prior to the pick-up date to request a cancellation and be refunded the entirety of your deposit. With 29 days or less, you may still request a cancellation, but may be subject to losing a portion of the deposit or the entire deposit. There is a \$500.00 deposit for travel trailers and a \$1,000.00 deposit for motor homes.

**Rules of the Road** While renting from Specialty RV Rentals, we ask that you please don't smoke or bring pets/animals of any kind into the rented unit. If you are going fishing, please store the fish in your personal cooler (it is difficult to remove the smell from the rented unit's fridge). We do not offer refunds on early returns. For motorhome users, generator usage is \$2.00 per hour of use. Rental pick-up times, which are scheduled in advance, are from 12:00 pm - 3:00 pm Monday - Friday and 9:00 am - 1:00 pm Saturday. Hours may vary depending on availability and holidays. Rental drop-off times are Monday - Saturday 8:30 am - 10 am. Returning a unit late can result in additional charges each hour the unit is late.
